Guidelines for Sportspersons and Professional Entertainers

General information

Sportspersons who are competing for prize money, and professional entertainers, may be eligible for assistance on the freight paid for transporting the equipment that they use for these activities.

For the purposes of the scheme

Sportspersons must be competing in a sporting event for prize money or other financial reward. The sporting event must be the primary purpose of the trip.

Professional entertainers must receive an income, fee or financial reward for performing in a show or event. The entertainment must be the primary purpose of the trip.

Equipment includes all things used directly in the entertainment or sporting event, for example, sideshow equipment, sound equipment, sports cars. It does not include living accommodation or personal vehicles.

Equipment must have been transported in a round trip between:

- mainland Australia and Tasmania,
- mainland Tasmania and King Island, or
- · mainland Tasmania and the Furneaux Group.

The freight costs must have been incurred and paid by either the sportsperson, the professional entertainer or the talent manager. Claims will not be accepted if the freight for the round trip is paid by more than one person.

Documentary requirements

The following documentation must be provided with your completed declaration:

- a completed Tasmanian Freight Equalisation Scheme Claim for Assistance Domestic goods (TAS002) form
- original invoices and copies of consignment notes for both legs of the round trip
- a completed Tasmanian Freight Equalisation Scheme Cargo and Trailer dimensions (TAS016)
 form detailing the configuration and the dimensions of the equipment shipped, and
- if this form is signed by a talent manager, a letter from the professional entertainer or sportsperson authorising the talent manager to claim on behalf of the professional entertainer or sportsperson.
