Notice of withdrawal of application for a child support assessment (CS1669)

When to use this form



Use this form to withdraw an application for assessment of child support at any time before the Child Support Registrar accepts the application.

You cannot withdraw an application once it has been accepted. However, you can end the assessment by completing an **Ending a child support assessment (CS1671)** form.

IMPORTANT: If you receive Family Tax Benefits (FTB) withdrawing or ending your application may affect your FTB payments. For more information, go to servicesaustralia.gov.au/csandftba
