# Joint election to stop a change to your child support assessment being initiated (CS2899)

	Use this form to elect to stop Services Australia initiating a change to the child support assessment.
$(\mathbf{i})$	We will notify both parties that the election has been accepted and stop the change to the assessment which we have initiated.
	We will notify both parties that the election has not been accepted. We will then decide whether a change to the assessment should be made.
Important information	We cannot accept the election if the receiving parent receives an income tested pension, allowance or benefit.
	Once we have formally accepted the election it cannot be withdrawn. Usually we will make a decision on the election within a few days of receiving it. However, if the election has not yet been accepted, either party may withdraw it. If you want to withdraw your election, and wish to find out whether or not it has been accepted, contact us on <b>131 272</b> .
Online account	You can access your Child Support online account through myGov. myGov is a secure way to access a range of government services online with one username and password. You can create a myGov account a <b>my.gov.au</b> and link your Child Support online account to it.
