

Manual identity verification for Provider Digital Access (HW080)

When to use this form

Use this form if you were unable to verify your identity online for your Provider Digital Access (PRODA) account.

Evidence of Identity

To finalise the registration of your PRODA account, you will need to verify your identity using:

- a Commencement of Identity document, and
- Use in the Community documents.

If your name differs between these documents, you may need to provide a change of name document.

Only provide accepted documents from the list shown or as requested by PRODA Support. These documents do not need to be certified, a copy of the original is accepted. Documents provided must be current at time of application.

A document can only be used once as either a Commencement of Identity or Use in the Community document.

Only legible, complete and official documentation can be accepted. Extracts of documents, ceremonial and commemorative certificates and low quality scanned or copied documents cannot be accepted.

A copy of a digital credential (for example, a myGov wallet digital Medicare card or Australia Post Keypass ID), is not acceptable identification for PRODA.

For your security

You must take all reasonable precautions to prevent loss, disclosure, modification, or unauthorised use of your PRODA access details.

You must create your own PRODA account using your own identity documents. Do not create an account for someone else.

Accepted documents

Change of name documents

Change of name documents are only needed if you have legally changed your name. If you have changed your name more than once, you need to document all name changes that link to your current name.

- Marriage certificate (ceremonial certificates are not accepted)
- Change of name certificate
- Amended Australian birth certificate
- Other official document issued from Births, Deaths and Marriages (BDM)

Commencement of Identity documents

You must provide one of the following documents.

- Australian passport
- Australian birth certificate (extracts and commemorative certificates are not accepted)
- Australian citizenship certificate (front and back)
- Australian immigration visa (supported by a foreign passport)
- Certificate of registration by descent
- ImmiCard

Use in the Community documents

You must provide at least **one** document from the **primary documents** list. Your primary document must be different to your chosen Commencement of Identity document. If you provide one primary document, you must also provide **one** document from the **secondary documents** list.

Primary documents

- Australian driver licence (front and back)
- ImmiCard
- Australian passport
- Australian immigration visa (supported by a foreign passport)
- Australian Government issued proof of age card or photo card
- Australian Working With Children or Working With Vulnerable Persons card (must include a photo)
- Australian secondary student document (you must be under 18 years of age and unable to provide another primary document), issued by a government agency or Australian school

Secondary documents

- Medicare card
- Department of Foreign Affairs and Trade (DFAT) issued Certificate or Document of Identity
- DFAT issued United Nations convention travel document
- Foreign government issued documents (for example, driver licence)
- Enrolment with the Australian Electoral Commission
- Security guard or crowd control photo licence
- Evidence of right to a government benefit (Department of Veterans' Affairs or Centrelink)
- Consular photo identity card issued by DFAT
- Police force officer photo identity card
- Australian Defence Force photo identity card
- Commonwealth, state or territory government photo identity card
- Aviation security identification card
- Maritime security identification card
- Firearms licence
- Credit reference check
- Australian tertiary student photo identity document
- Australian secondary student photo identity document
- Certified academic transcript from an Australian university
- Signed bank or credit card (front and back cover the security code)
