# Notes for your claim for ABSTUDY Allowances and Part-time Award

#### When to use this form



Use this form if you are an Australian Aboriginal or Torres Strait Islander and wish to claim ABSTUDY as a:

- part-time student
- full-time student who wish to claim non-means-tested ABSTUDY allowances only (including Incidentals Allowance)
- Australian Apprentice who wish to claim Incidentals Allowance only, or
- seeking assistance to attend a Testing and Assessment activity to gain entry to either:
  - a tertiary course, or
  - an enabling course at university.

If you are a full-time student or an Australian Apprentice, you can claim by calling us on **1800 132 317** or by completing the **Claim for ABSTUDY (SY019)** form.

#### **Online account**



Many of our customers find it easier to update their details using their Centrelink online account or Express Plus Centrelink mobile app.

## **Important information**

Check that all required questions are answered.

Return this form and any supporting documents to us **within 14 days** so we can process your application or claim. If you cannot do this **within 14 days**, you must contact us at the earliest possible date to make an arrangement.

You must return **all** supporting documents at the same time you lodge this claim form. If you do not return all documents, your claim may not be accepted. The only exception will be if you are waiting for medical evidence or other documents from a third party.

### **Eligibility**

#### Training and government assistance for study (questions 4-5)

Generally students who are receiving training assistance for formal study, including assistance from an employer, are not eligible for ABSTUDY. Training assistance from an employer includes paid study leave or the payment of all travel, meals and accommodation costs. If your employer gets an Australian Government or state or territory government wage subsidy on your behalf, you cannot get ABSTUDY.

The exceptions are:

- Australian Apprentices who are receiving training assistance for formal study or who are assisted through an Australian Government or state or territory government wage subsidy via an employer, for example, Priority Wage Subsidy (PWS)
- people doing a training program placement
- employees of organisations that are registered by the Australian Charities and Not-for-profit Commission (ACNC) and/or the Office of the Registrar of Indigenous Corporations (ORIC)
- scholarships, cadetships or similar assistance received from an employer (this does not include government employees receiving scholarships from their agency to study).

If you are employed, you need to ask your employer if they are registered by ACNC and/or ORIC for that exception to apply to you otherwise, you might not be eligible for ABSTUDY.

ABSTUDY cannot be paid if the same assistance is covered by your employer.

Examples of training assistance include:

- Living Away From Home Allowance (LAFHA) or payment of course fees or training costs for Australian Apprentices
- assistance from an employer for job related training (through an approved course) including:
  - paid study leave
  - the payment of all travel, meals and accommodation costs associated with doing the course or training away from your home.

If you receive other government assistance, for example, Youth Allowance or JobSeeker Payment, and:

- you are studying part-time, you can receive ABSTUDY part-time entitlements
- the study you are doing makes up part or all of your mutual obligation requirements and is a compulsory activity in your Job Plan, you will not be eligible for ABSTUDY assistance.

Mutual obligation requirements means an Activity Test or participation requirement under the *Social Security Act 1991*.

# **Payments**

#### **Part-time students**

If you are a part-time student, you can qualify for the ABSTUDY Part-time Award if you meet the general ABSTUDY eligibility criteria and are either studying a:

- post-secondary course
- secondary course and are 18 or older on 1 January of the year of study.

Depending on your circumstances, you may qualify for ABSTUDY Incidentals Allowance, Away from Base assistance and/or Fares Allowance to attend Away from base activities.

If you are a tertiary student approved for the Part-time Award, you may also be entitled to Living Allowance for the duration of an Away from base activity if you lose your income while attending the activity.

#### **Full-time students**

If you are a full-time student who meets the general ABSTUDY eligibility criteria, you may wish to apply for the non-means-tested ABSTUDY allowances only. Depending on your circumstances, you may qualify for ABSTUDY Incidentals Allowance, Additional Incidentals Allowance, Fares Allowance and/or assistance to attend Away from base activities.

As a full-time student, you may also qualify for fortnightly Living Allowance, depending on your income. If you wish to apply for payment of Living Allowance, you can call us on **1800 132 317** or complete the **Claim for ABSTUDY (SY019)** form.

#### **Australian Apprentices**

If you are an Australian Apprentice who meets the general ABSTUDY eligibility criteria, you may wish to apply for ABSTUDY Incidentals Allowance only.

As an Australian Apprentice, you may also qualify for fortnightly Living Allowance, depending on your income. If you wish to apply for payment of Living Allowance, you can call us on **1800 132 317** or complete the **Claim for ABSTUDY (SY019)** form.

#### **Incidentals Allowance**

Incidentals Allowance is available for full-time and part-time students, and Australian Apprentices. It is available to tertiary students and students enrolled in a secondary level preparatory (bridging, access or enabling) course at a higher education institution that is designed to help people gain entry to higher education level courses. Other secondary students can also get Incidentals Allowance but must be 18 or older on 1 January of the year of study.

Incidentals Allowance helps you pay for general course expenses. It is paid at the beginning of your course or Australian Apprenticeship for the year. The amount paid depends on the period of your course enrolment or Australian Apprenticeship for the calendar year.

Incidentals Allowance is not means tested. This means if your income stops you receiving Living Allowance, you may still qualify for Incidentals Allowance.

If you are a full-time tertiary, Masters or Doctorate student who has high essential course costs, 'Additional' Incidentals Allowance may be available.

#### **Testing and Assessment**

If you need to travel away from home to attend a selection test, assessment or interview for entry into an enabling course at a university or a tertiary course, ABSTUDY assistance may be available to help cover the costs of travel, meals and accommodation.

ABSTUDY will help you to attend only 2 selection tests or interviews in a year.


## Study details

#### **Proof of student status**

If you are a student, you will need to provide proof of enrolment from the institution if you are doing one of these courses:

- · higher education course
- · vocational education and training course at a TAFE or higher education institution
- secondary course at a TAFE or higher education institution or any course at a private education provider,
- you have not previously claimed ABSTUDY for these courses or you are starting a new course.

You must provide a copy of the notice you were given by your institution **within 14 days** of starting studies. Secondary school students and students in a higher education course at university are not required to provide proof of enrolment.
