

Run off Cover Indemnity Scheme Overseas medical practitioner

When to use this form

The statutory declaration attached to this form must be completed when a copy of the medical practitioner's visa is not available to support eligibility under the Run off Cover Indemnity Scheme (ROCS).

The statutory declaration must be completed by the overseas medical practitioner on or after the date they leave Australia.

The ROCS only applies to claims or incidents first notified to the Medical Defence Organisation (MDO) or Medical Indemnity Insurer (MII) **on or after 1 July 2004**.

Note 1 Chapter 2 of the *Criminal Code* applies to all offences against the *Statutory Declarations Act 1959* — see section 5A of the *Statutory Declarations Act 1959*.

**A statutory declaration under section 9 of the
Statutory Declarations Act 1959 may be made before –**

- (1) a person who is currently licensed or registered under a law to practice in one of the following occupations:
 - Architect
 - Chiropractor
 - Dentist
 - Financial adviser
 - Financial Planner
 - Legal practitioner
 - Medical practitioner
 - Midwife
 - Migration agent registered under Division 3 of Part 3 of the *Migration Act 1958*
 - Nurse
 - Occupational therapist
 - Optometrist
 - Patent attorney
 - Pharmacist
 - Physiotherapist
 - Psychologist
 - Trade marks attorney
 - Veterinary surgeon
- (2) a person who is enrolled on the roll of the Supreme Court of a state or territory, or the High Court of Australia, as a legal practitioner (however described); or
- (3) a person who is in the following list:
 - Accountant who is:
 - (a) a fellow of the National Tax Accountants' Association; or
 - (b) a member of any of the following:
 - i. Chartered Accountants Australia and New Zealand;
 - ii. the Association of Taxation and Management Accountants;
 - iii. CPA Australia;
 - iv. the Institute of Public Accountants
 - Agent of the Australian Postal Corporation who is in charge of an office supplying postal services to the public
 - APS employee engaged on an ongoing basis with 5 or more years of continuous service who is not specified in another item in this list
 - Australian Consular Officer or Australian Diplomatic Officer (within the meaning of the *Consular Fees Act 1955*)
 - Bailiff
 - Bank officer with 5 or more continuous years of service

 - (a) a member of Engineers Australia, other than at the grade of student; or
 - (b) a Registered Professional Engineer of Professionals Australia; or
