

## Run off Cover Indemnity Scheme Midwife who has ceased practice because of maternity

### When to use this form

The midwife completing the statutory declaration attached to this form, must have temporarily or permanently ceased midwifery practice because of maternity.

The Midwife Professional Indemnity Run off Cover only applies to claims or incidents first notified to your Medical Indemnity Insurer (MII) **on or after 1 July 2010**.

### Private practice as an eligible midwife

Private practice as an eligible midwife is defined in Section 31(5) of the *Midwife Professional Indemnity (Commonwealth Contribution) Scheme Act 2010* to mean practice as an eligible midwife other than:

- practice consisting of treatment of public patients of a hospital; or
- practice for which:
  - the Commonwealth, a State or a Territory; or
  - a local governing body; or
  - an authority established under a law of the Commonwealth, a State or a Territory;indemnifies eligible midwives from liability relating to compensation; or
- practice conducted outside both Australia and the external Territories; or
- practice of a kind specified in the Rules.

**Note 1** Chapter 2 of the Criminal Code applies to all offences against the *Statutory Declarations Act 1959* — see section 5A of the *Statutory Declarations Act 1959*.

**A statutory declaration under section 9 of the  
Statutory Declarations Act 1959 may be made before –**

- (1) a person who is currently licensed or registered under a law to practice in one of the following occupations:
  - Architect
  - Chiropractor
  - Dentist
  - Financial adviser
  - Financial Planner
  - Legal practitioner
  - Medical practitioner
  - Midwife
  - Migration agent registered under Division 3 of Part 3 of the *Migration Act 1958*
  - Nurse
  - Occupational therapist
  - Optometrist
  - Patent attorney
  - Pharmacist
  - Physiotherapist
  - Psychologist
  - Trade marks attorney
  - Veterinary surgeon
- (2) a person who is enrolled on the roll of the Supreme Court of a state or territory, or the High Court of Australia, as a legal practitioner (however described); or
- (3) a person who is in the following list:
  - Accountant who is:
    - (a) a fellow of the National Tax Accountants' Association; or
    - (b) a member of any of the following:
      - i. Chartered Accountants Australia and New Zealand;
      - ii. the Association of Taxation and Management Accountants;
      - iii. CPA Australia;
      - iv. the Institute of Public Accountants
  - Agent of the Australian Postal Corporation who is in charge of an office supplying postal services to the public
  - APS employee engaged on an ongoing basis with 5 or more years of continuous service who is not specified in another item in this list
  - Australian Consular Officer or Australian Diplomatic Officer (within the meaning of the *Consular Fees Act 1955*)
  - Bailiff
  - Bank officer with 5 or more continuous years of service

    - (a) at a place outside Australia; and
    - (b) authorised under paragraph 3(c) of the *Consular Fees Act 1955*; and
    - (c) exercising the employee's function at that place
  - Engineer who is:
    - (a) a member of Engineers Australia, other than at the grade of student; or
    - (b) a Registered Professional Engineer of Professionals Australia; or
    - (c) registered as an engineer under a law of the Commonwealth, a state or territory; or
    - (d) registered on the National Engineering Register by Engineers Australia
  - Finance company officer with 5 or more years of continuous service
  - Holder of a statutory office not specified in another item in this list
  - Judge
  - Justice of the Peace
  - Magistrate
  - Marriage celebrant registered under Subdivision C of Division 1 of Part IV of the *Marriage Act 1961*
  - Master of a court
  - Member of the Australian Defence Force who is:
    - (a) an officer
    - (b) a non-commissioned officer within the meaning of the *Defence Force Discipline Act 1982* with 5 or more years of continuous service

  - Member of the Governance Institute of Australia Ltd
  - Member of:
    - (a) the Parliament of the Commonwealth
    - (b) the Parliament of a state

  - Minister of religion registered under Subdivision A of Division 1 of Part IV of the *Marriage Act 1961*
  - Notary public, including a notary public (however described) exercising functions at a place outside
    - (a) the Commonwealth
    - (b) the external territories of the Commonwealth
  - Permanent employee of the Australian Postal Corporation with 5 or more years of continuous service who is employed in an office providing postal services to the public

    - (a) a state or territory or a state or territory authority
    - (b) a local government authoritywith 5 or more years of continuous service, other than such an employee who is specified in another item of this list
  - Person before whom a statutory declaration may be made under the law of the State or Territory in which the declaration is made
