# Income declaration – Income earned outside Australia (CS4145)

### When to use this form



Use this form to provide a declaration of your income earned outside Australia, or a combination of income earned outside Australia and Australian income.

Services Australia uses your income to calculate your Australian child support assessment.

**IMPORTANT**: If better information is available from a court or administrative authority in your country, we may replace your income declaration with the income information received from that authority and reassess your child support. It is important that the information you provide in this form is correct.

We may ask you to provide evidence of this income if there is a dispute, or we get information suggesting your income needs to be reviewed.

# **Online account**



You can access your Child Support online account through myGov. myGov is a secure way to access a range of government services online with one username and password. If you do not have a myGov account, you can create one at **my.gov.au** and link Child Support to it.

## **Income details**

To calculate your child support assessment, both parents' income is used. This includes Australian income and income earned outside Australia for the last financial (tax) year.

The financial year varies between countries. In Australia the financial year begins on 1 July and ends on 30 June the following year. Provide financial year incomes not previously provided to us relevant to your child support case. If you are unsure what financial year(s) you need to provide income for, contact us to discuss.

We will use the relevant exchange rate to convert all currencies into Australian dollars.
