Family Tax Benefit pre-birth claim

Unta paka inatjina katjia kurrka, unta paka arrarnalitjika Family Tax Benefit (FTB) pre birth claim 3 month arrkurla unkwanga katjia kurrka intamanga.

Unta paka arrarnatjika FTB pre birth claim unta inatjika:

- unkwanga Tax File Number (TFN) or unta paka mita kurta namalanga nurna antjanama ekuranha Tax File Number-ka
- Customer Reference Number (CRN) unkwanganhaka
- unta nthitjika bank account unkwanganha Centrelink-la etna parta nganha pay-melitjinanga.

Unta paka itja TFN kerta unta lhatjika service centre-urna angkitjika Services Australia (Centrelink)-lela etna paka pmara unkwanga-urna lhama.

Unta paka inamanga katjia kurrka hospital workern ntjaarrala nthama nganha pepa nhanha ntjarra kngitjika Centrelink urna unta paka FTB pre-birth claim mpaaratjinanga and arrarnatjika katjia kurrka unkwanganha Medicare card-ka.

Unta paka yia wutha wutjika antjanama

Unta paka yia wutha wutjika antjanama, nhanha aratjika:

- unta lhatjika etnanha aratjika Services Australia (Centrelink) service centre pmara unkwanganhanga
- unta angkitjika Services Australia (Centrelink)-lela etna pitjimanga pmara unkwanganha-urna
- unta ring-melitjika Indigenous Call Centre nhanhanga 1800 136 380.

Unta paka nurnanha ring-melamala, nurnaka ilatjika Customer Reference Number (CRN) unkwanganha, ilatjika yia unkwanga epenha turta. Nurna lhangkaratjinanga nganha.

Unta ring-melamanga, thunga unta pitjimanga nurnanha aratjika, unta paka antjanama interpreter-ka, nurna nganha free one nthima.

Family Tax Benefit pre-birth claim

If you are going to have a baby, you can start to get your Family Tax Benefit (FTB) pre birth claim ready 3 months before your baby is born.

To start your FTB pre birth claim you will need to get:

- your Tax File Number (TFN) and if you have a partner, we need their TFN
- your Customer Reference Number (CRN)
- a bank account for your money so we can pay you.

If you do not have a TFN, you can apply for one by visiting your local service centre or talking to Services Australia (Centrelink) when they visit your community.

When you have the baby, the hospital will give you important papers about your new baby. You need to bring these papers to Centrelink to finish your FTB pre-birth claim and add your new baby to your Medicare card.

If you need more information you can:

- visit your local Services Australia (Centrelink) service centre
- talk to Services Australia (Centrelink) when they visit your community
- call the Indigenous Call Centre on 1800 136 380.

If you call us, you will need to tell us your Customer Reference Number (CRN) and answer some questions about who you are, so that we make sure it is you.

You can also ask for an interpreter when you call or visit us. We will provide one for free.
