



## Family Tax Benefit pre-birth claim

Family Tax Benefit (FTB) ny-ma barra, gu-gata wenga FTB claim start nyi-ni barra mu-ngoyurra nuwurra luka minypa gama, an-delipa nyi-gochila a-yurra munurdiya minypa mun-nelangga pre birth FTB claim nyi-ni barra 3 ran.gu ana-jinyjirra.

FTB pre birth claim start nyi-ni barra:

- Burr-wu barra Tax File Number (TFN) rrapa an-gumarrbipa, o jin-gumarrbipa mun-nika TFN nyirrbu-gurdagarraga barra nyirrbu-wu barra TFN nula. Rrapa gun-nerranga gala n-dima TFN an-mujama aburr-gunggajiya barra nggula TFN nula, ny-ma barra. Boy burr-na, service centre gu-nginyipa rrawa yi-gurrepa nyi-nirra. Luka nginyipa burr-wenggana barra aburr-mujama aburr-welangga Services Australia (Centrelink) gun-gata birripa aburr-bengga barra yi-gatiya community.
- Burr-wu barra gun-nginyipa Customer Reference Number (CRN) luka bubu-wenggana barra nyi-nga ny-yelangga luka ny-nyurrjiya barra ny-yelangga nginyipa.
- Mun-nginyipa bank account Centrelink marn.gi burr-naga barra barra rrupiya yi-gatiya miy-barnja nggula.

Gu-gata wenga Centrelink burr-wu barra mu-jurra gu-guyinda a-rrima barra a-yu. Gu-gata wenga Centrelink miy-jarlapa barra FTB pre-birth claim. Barra yanma Medicare card a-rrima a-yu luka Centrelink burr-wu barra.

## Family Tax Benefit pre-birth claim

If you are going to have a baby, you can start to get your Family Tax Benefit (FTB) pre birth claim ready 3 months before your baby is born.

To start your FTB pre birth claim you will need to get:

- your Tax File Number (TFN) and if you have a partner, we need their TFN
- your Customer Reference Number (CRN)
- a bank account for your money so we can pay you.

If you do not have a TFN, you can apply for one by visiting your local service centre or talking to Services Australia (Centrelink) when they visit your community.

When you have the baby, the hospital will give you important papers about your new baby. You need to bring these papers to Centrelink to finish your FTB pre-birth claim and add your new baby to your Medicare card.

### If you need more information you can:

- visit your local Services Australia (Centrelink) service centre
- talk to Services Australia (Centrelink) when they visit your community
- call the Indigenous Call Centre on 1800 136 380.

If you call us, you will need to tell us your Customer Reference Number (CRN) and answer some questions about who you are, so that we make sure it is you.

You can also ask for an interpreter when you call or visit us. We will provide one for free.
