Nungkwu-wa kimena-manaja enena Family Tax Benefit akwa warna wurrindarringba akwa wurrungwarringba nalalikajuma kembirra ningkena kimenama Child Support.

Arakba kimena-manja ena Family Tax Benefit, nungkuwa kiyamenama jurra amirndakeni-manja 13 weeks nara-manja ayamama ena Child Support kema ayukwijiya kimenama families (Family Tax Benefit) awarnda. Kiyamina ena Child Support claim.

Amiyabena ena Child Support

Ena Child Support awarnda wurrakina-langwa wurrindarringba akwa wurrungwarringba bimamirrikajina-ma kakwurrajini-yada wurriyukwayuwa.

Kajungwa kimeni-yada families-langwa awarnda kakumamirrikajini-yada wurrumirndakakina-yada wurriyukwayuwa.

Nara-manja ayakajuma wurrindarringba akwa wurrungwarringba nungkuwurra yikimamurrikena yikakurrajina nungkwurri-langwa warrijuwa.

Nungkuwa kimena Child Support biya yirruwa yibamakinama nungkuwawa akwa abirri-langwa wurrungwarringba kabendenama abirruwa Child Support akwa ambarringarna awarnda kabadenama. Warna Services Australia Child Support warnikuwardidwarda karimenama ena awarnda.

Nikarnikidirrika-langwa enena yirruwa yikabirrangkinama akabirra abirra-langwa wurrundarringba akwa wurrungwarringba. Kembirra yirruwa kangkilabajama ayakwa akwa kakunama jurra-miya yirruwa yikiyangbinama wurrungwarringba.

Kingendena-manja enena Child Support kiyangbina yirru-langu-wa Child Support warnikuwardidwarda.

Ena abiyakarribiya kiyuwarnama amalika-langwiya kimeni-yada Child Support:

1. Yirru-langwa Child Support warni kuwardidwarda yikarrumidukunama awarnda nungkwu-langwa:
  - ena eningaba kuwangkarrini-yada
  - yikikimadina-manja karnikiyangba abirru-langwa wurrangwarringba akwa wurrindarringba akina-langwa Child Support
  - kirkakina yikakunama awarnda ebina-manja kabiminyangbijinama akwa ambarringarna
  - nungkuwa kamamirrika-jina-ma kimenama Child Support awarnda
  - wurrakina abirri-langwa wurrindarringba akwa wurrungwarringba nara-manja ayamama abirri-langwa tax returns.
2. Self Managed plan. Ena arnimakukawura ningki yarrkakuminama ayakwa abirri-langwa-manja wurrungwarringba. Enena Self Managed Plan kirngedenama amirdakidirribirra kuwangkarrina-ma.
  - ambarringarna Child Support kimena-ma

- ngambiyada wurrindarringba akwa wurrungwarrba kabukunama ena Child Support awarnda.

Yirra-langwa Child Support staff nara akumajayijunguma enena-manja plan.

Ena kingdena-manja enena plan kamba awarnikikwujiya families awarnda kimena-ma.

3. Private Collect plan. Ena ngarrakimakinama warna Child Support warnumamalya akwa kuda-langwa warnumamalya ambarringarna Child Support kakunama awarnda wurrindarringbawa dukwa wurrungwarrbawa biya nungkurru-wa yikingebirra kinama plan kayamarrikinama kabakunama nungkuwa-wa.

Nungkuwa kingendena-manja akwala ayakwa kilikaja:

- kingarena nungkuw-langwa Services Australia (Centrelink) service centre
- kiyangbina warnuwa Services Australia (Centrelink) kingarrena-manja nungkuw-langwa community
- karnda-majina Indigenous Call Centre 1800 136 380 akwa kangkilabaja kiyangbini-yada Indigenous Child Support warnumamalya.

Yikarndamajina-manja yirruwa yikimakina nungkuw-langwa Customer Reference Number (CRN) akwa yikimakina ayakwa akabirra ningkena yirruwa yirra kakurumi-yada ningkakina nungkuw-wa.

Yikangkilabaja yikangedena-manja interpreter nungkuwurra yikarnda-majina warna interpreter yikabimamirrikajini-yada yakwujina nara abenduma awarda erribirra warna.



# How Child Support affects your Family Tax Benefit

If you are getting Family Tax Benefit and you and the birth parent of your kid or kids are not together, you might need to apply for child support.

When you start getting Family Tax Benefit, you get 13 weeks to apply for child support. After 13 weeks, if you have not applied for child support you will get less families (Family Tax Benefit) money until you do a Child Support claim.

What is child support.

Child support is money the other birth parent or parents pay to help you look after them.

This is so you get enough families money to help you look after your kid or kids.

Even if you and the other birth parent of your kid are not together you both need to look after your kids.

You can claim Child Support and we can tell you and the other birth parent who needs to pay child support and how much they have to pay. Services Australia Child Support staff can also collect this money for you.

To accept your claim we need to check who the birth parents of the kids are, we may need you to answer some questions or give us some paperwork. We will usually need to talk to the other birth parent.

To apply for child support you will need to talk to our Child Support staff.

There are 3 ways for you to get child support:

1. Our Child Support staff can collect the money for you if:
  - this makes things simpler and easier for you
  - it is hard to talk with the other birth parent of your kid or kids about child support
  - you need help to make sure payments are on time and the right amount
  - you need help to get child support money back on track
  - the other birth parent does not lodge their tax returns.
2. Self Managed plan. This is a private agreement between you and the other birth parent, or parents of your kid or kids. With a Self Managed plan you both choose:
  - how much child support money will be paid
  - when the other birth parent of your kid or kids will pay the child support money.

Our Child Support staff do not need to be part of this plan.

If you choose this plan, you may get less families money.

3. Private Collect plan. This means our Child Support people or courts have said how much child support money the other birth parent of your kid or kids has to pay. All you and the other birth

parent have to do is make a plan about how they will pay you and when the money will be paid.

If you need more information you can:

- visit your local Services Australia (Centrelink) service centre
- talk to Services Australia (Centrelink) when they visit your community
- call the Indigenous Call Centre on 1800 136 380 and ask to speak to the Indigenous Child Support people.

If you call us, you will need to tell us your Customer Reference Number (CRN) and answer some questions about who you are, so that we make sure it is you.

You can also ask for an interpreter when you call or visit us. We will provide one for free.
