Ngaw, minyja Family Tax Benefit ny-mangga nula ny-yorkiya an-delipa, nginyipa rrapa an-gumarrbipa, nyirri-bawachichiyana ana-nga luka jaga a-gana barra nula an-delipa, barra minypa child support ana-nga mu-ma barra a-ji.

Minypa Family Tax Benefit ny-manga nula, luka burr-wenggana barra child support nula, minypa 13 weeks guna-jinyjirra barra burr-wenggana barra yibirrich. Galaypa families (Family Tax Benefit) mun-delipa ny-man rrupiya. Wurra burr-wenggana barra Child Support nula rrapa Family Tax Benefit barra mu-warrcha minypa rrupiya wana mu-ni.

Nginyipa marn.gi child support?

Minypa muma rrapa nyinya an-birrinyjipa delipa nyirriny-bawachichiya barra nyirriny-yorkiya, minypa abirriny-bokamapa an-delipa an-gubokumapa still jiny-yu barra, child support.

Mun-guna rrupiya families mun-nika jaga mun-guni an-gungarda mun-nika.

Gun-gata minypa abirriny-bapawuchichiya barra, still barra abirriny-yuchichiya barra an-gungarda.

An-gungarda mun-nika Child Support burr-wenggana barra. Services Australia Child Support an-mujama a-wengga barra burrinyjila, jin-gubokamapa rrapa an-gubokamapa ana-nga barra an-gungarda mun-nika rrupiya mu-ma. Services Australia Child Support aburr-mujama aburr-gunggajiya barra nggula, an-gungarda mun-nika Child Support.

Minyja jal nyi-ni child support ny-ma barra, nginyipa burr-wenggana barra Child Support aburr-mujama.

Gun-ngardapa rrapa abirri-jirrapa guna-jinyjirra child support nula minypa 3 ways gu-meya:

- 1. Birripa Child Support aburr-mujama wenga barra mbi-ma rrupiya child support mun-nginyipa:
  - Ngardawa gun-guna minypa ngika gun-derta wurra marr gun-mola wenga.
  - Minypa ny-jurnjinga an-gungarda child support nula, gala abirriny-yinmiya abirriny-yengga an-gubokamapa o jin-gubokamapa.
  - Nuwurra Services Australia a-gunggajiya barra, jechinuwa gu-naga barra, an-gungarda mun-nika rrupiya child support.
  - Gun-guna gun-nerranga janguny an-gubokamapa o jin-gubokamapa gala lodge abirrinyi-ni tax return.
- 2. Gun-guna minypa ngardapa barra Self Managed Plan nyirriny-yinda barra. Gun-guna minypa ana-gorrinyjipa jama nyirriny-ji barra wigipa, luka ana-nga barra rrupiya child support pay a-ni barra brom ana-gorrinyjipa wenga.
  - Ana-gorrnyjipa barra nyirriny-yengganichichiya barra ana-nga barra mun-bapurru rrupiya an-gungarda mun-nika

• mu-yinpa mun-nelangga child support mu-ma barra a-ni.

Gun-gata Self Managed Plan aburr-mujama Child Support wenga gala aburr-yinmiya aburr-gunggajiya nggula child support nula. Nuwurra waypa nyiburr-bamagutuwuchichiya barra, luka nyiburr-wengganachichiya barra. Jechinawa nyibu-naka barra child support rrupiya families munnika.

Wurra, aburr-wengga barra rrupiya mun-bapurru mubu-ngurrja barra minypa marr mun-delipa ny-ma barra.

3. Gun-guna gun-nerranga janguny gun-nelangga Private Collect Plan. Child Support aburr-mujama rrapa court marn.gi nyirrrbu-naka barra ana-nga o jin-nga rrupiya mu-ma barra.

Jal nyiburr-nirra barrwa information:

- nyiburr-boy barra Services Australia (Centrelink) service centre yi-gurrepa rrawa nyiburr-nirra
- minypa burr-wenggana barra Services Australia (Centrelink) aburr-mujama yi-gata minypa birripa aburr-boy barra gurda Maningrida

## How Child Support affects your Family Tax Benefit

If you are getting Family Tax Benefit and you and the birth parent of your kid or kids are not together, you might need to apply for child support.

When you start getting Family Tax Benefit, you get 13 weeks to apply for child support. After 13 weeks, if you have not applied for child support you will get less families (Family Tax Benefit) money until you do a Child Support claim.

What is child support.

Child support is money the other birth parent or parents pay to help you look after them.

This is so you get enough families money to help you look after your kid or kids.

Even if you and the other birth parent of your kid are not together you both need to look after your kids.

You can claim Child Support and we can tell you and the other birth parent who needs to pay child support and how much they have to pay. Services Australia Child Support staff can also collect this money for you.

To accept your claim we need to check who the birth parents of the kids are, we may need you to answer some questions or give us some paperwork. We will usually need to talk to the other birth parent.

To apply for child support you will need to talk to our Child Support staff.

There are 3 ways for you to get child support:

- 1. Our Child Support staff can collect the money for you if:
  - this makes things simpler and easier for you
  - it is hard to talk with the other birth parent of your kid or kids about child support
  - you need help to make sure payments are on time and the right amount
  - you need help to get child support money back on track
  - the other birth parent does not lodge their tax returns.
- 2. Self Managed plan. This is a private agreement between you and the other birth parent, or parents of your kid or kids. With a Self Managed plan you both choose:
  - how much child support money will be paid
  - when the other birth parent of your kid or kids will pay the child support money.

Our Child Support staff do not need to be part of this plan.

If you choose this plan, you may get less families money.

3. Private Collect plan. This means our Child Support people or courts have said how much child support money the other birth parent of your kid or kids has to pay. All you and the other birth

parent have to do is make a plan about how they will pay you and when the money will be paid.

If you need more information you can:

- visit your local Services Australia (Centrelink) service centre
- talk to Services Australia (Centrelink) when they visit your community
- call the Indigenous Call Centre on 1800 136 380 and ask to speak to the Indigenous Child Support people.

If you call us, you will need to tell us your Customer Reference Number (CRN) and answer some questions about who you are, so that we make sure it is you.

You can also ask for an interpreter when you call or visit us. We will provide one for free.
