

Nhaltjanli Child Supportdhuny affect nhungu Family Tax Benefit

Ngunhiyi nhe ga marram Family Tax Benefit ga nhe ga wiripu ngunhiyi birth parent nhuma yakan ga nhina rrambangi, mak nhe dhu ngangthun child supportgu.

Balanymirriy nhe dhu ngurriyirryuna marranhangur Family Tax Benefitdja, 13 weeks nhunany dhu gurrupan ngangthunaraw child supportguny. Djulkthun dja dhu 13 weeksdja, ngunhiyi nhe bayngu nganthun child supportgu nheny dhuka marr lurrkun nha marram families (Family Tax Benefit) rrupiyany yan bili nhe dhu ngangthun Child Supportgu.

Nha child supportdja

Child supportdja rrupiya wiripuy li birth parent wu parentsdhu gurrupan gungayyunaraw nhungu djakaw walalang.

Dhuwandja marrka nhe dhu gana ga families rrupiya marram djakaw nhungu yothu wu djamarrkuliw.

Baythi nhe ga wiripu birth parent ngurukiyi yothuw yakan ga rrambangi nhina djaka nhuma dhuka rrambangi yan.

Nhe balang claim Child Support gu limurr balang lakarang nhokal ga wiripu wal birth parentgal yolthu dhuka gurrupan child support ga nhamunha ngayi dhuka wunguliyun. Services Australia Child Support djamamirriy mala balang wiripuny gi marrang ngunhiyi rrupiya nhungu.

Acceptguny nhungu claimguny limurrdja dhu check yol ngayi birth parents dja mandany djamarrkuliw dja, limurr mak dhu ngangthun questions mala wu djorraw mala. Usually'ny limurrli need wanganharaw wiripu wal birth parentgal.

Apply child supportguny needdja nhe dhu wanga limurrungal Child Support djamamirri wal.

3 dhukarrdja marranharaw child supportguny:

- 1. Limurrungal Child Support djamamirriy balang gi marrang rrupiya nhungu ngunhiyi balang:
 - dhiyang nhungu simpler ga easiergung
 - gummurdal wanganharaw wiripuwal birth parentgal yothuw nhungu wu djamarrkuliw child supportbuy
 - gungayyunaraw nhe need ngayithu payments mala ga on time marrtji ga right yan amount
 - gungayyunaraw nhe need marrka dhu child support rrupiya bulu rongiyinmaram on tracklil
 - wiripuy lika birth parentdhu bayngu lodge tax returns mala.
- 2. Self Managed plan. Dhuwandja private agreement nhungu ga wiripu birth parentgu wu parents mala nhungu yothuw wu djamarrkuliw. Self Managed plandhuny nhuma dhu marrmay djarryun:
 - nhamunha child support rrupiyany dhuka marram
 - balanyamirriy nha ngayidhu wiripuy parentdhu nhungu yothuw wu djamarrkuliw gurrupandja child support rrupiya.

Limurrung Child Support staff yaka ga need ngayi dhu part ngunhili planngur.

Ngunhiyi nhe dhu djarryun dhuwandja plan, mak nhe dhuka marr lurrkun nha families rrupiya marram.

3. Private Collect plan. Dhuwandja mayali limmurrung Child Supportpuy yu mala wu courts dhu lakarangala nhamunha child support rrupiya dhuka gurrupan wiripuy birth parentdhu nhungu yothuw wu djamarrkuliw. Nhe ga wiripuy dja birth parentdhuny yan dhu ngamangamayun plan nhaltjan ngayi dhuka wunguliyun nhunany ga nhatha nhe dhuka rrupiya marram.

Ngunhiyi nhe djal bulu informationgu, nhe balang:

- doyyurr nhungu local Services Australia (Centrelink) service centre'w
- wangi Services Australia (Centrelink) wal balanyamirri walal dhu visit nhungu community
- call Indigenous Call Centre'w dhipal 1800 136 380 ga ngangthurr wanganharaw Indigenous Child Supportgu mala.

Ngunhiyi nhe dhu calldja limurrung, lakaram nhe dhu Customer Reference Number (CRN) ga bukubakmaram questions mala nhokalangawuy marrka limurr marngi ngunhiyi yuwalk nhe.

Nhe balang ngangthurr interpreter'w balanyamirriy nhe dhu visit dja limurruny. Limurr dhu provide wangany nhungu wunguliyuna miriw.



How Child Support affects your Family Tax Benefit

If you are getting Family Tax Benefit and you and the birth parent of your kid or kids are not together, you might need to apply for child support.

When you start getting Family Tax Benefit, you get 13 weeks to apply for child support. After 13 weeks, if you have not applied for child support you will get less families (Family Tax Benefit) money until you do a Child Support claim.

What is child support.

Child support is money the other birth parent or parents pay to help you look after them.

This is so you get enough families money to help you look after your kid or kids.

Even if you and the other birth parent of your kid are not together you both need to look after your kids.

You can claim Child Support and we can tell you and the other birth parent who needs to pay child support and how much they have to pay. Services Australia Child Support staff can also collect this money for you.

To accept your claim we need to check who the birth parents of the kids are, we may need you to answer some questions or give us some paperwork. We will usually need to talk to the other birth parent.

To apply for child support you will need to talk to our Child Support staff.

There are 3 ways for you to get child support:

- 1. Our Child Support staff can collect the money for you if:
 - this makes things simpler and easier for you
 - it is hard to talk with the other birth parent of your kid or kids about child support
 - you need help to make sure payments are on time and the right amount
 - you need help to get child support money back on track
 - the other birth parent does not lodge their tax returns.
- 2. Self Managed plan. This is a private agreement between you and the other birth parent, or parents of your kid or kids. With a Self Managed plan you both choose:
 - how much child support money will be paid
 - when the other birth parent of your kid or kids will pay the child support money.

Our Child Support staff do not need to be part of this plan.

If you choose this plan, you may get less families money.

3. Private Collect plan. This means our Child Support people or courts have said how much child support money the other birth parent of your kid or kids has to pay. All you and the other birth

parent have to do is make a plan about how they will pay you and when the money will be paid.

If you need more information you can:

- visit your local Services Australia (Centrelink) service centre
- talk to Services Australia (Centrelink) when they visit your community
- call the Indigenous Call Centre on 1800 136 380 and ask to speak to the Indigenous Child Support people.

If you call us, you will need to tell us your Customer Reference Number (CRN) and answer some questions about who you are, so that we make sure it is you.

You can also ask for an interpreter when you call or visit us. We will provide one for free.
