

## Nyarrparlu ka Child Support-rlu affect-i mani nyuntu nyangu Family Tax Benefit

Kajinpa mani Family Tax Benefit manu nyuntu manu nyuntu nyangu kurdu-kurduku palangu nati kanpala nyinami mapirri, ngulaju kaji kanpa apply jarrimi child support-ku.

Kajinpa start-jarrimi Family Tax Benefit maninjaku, ngulaju 13 weeks puru juku apply jarriya child support kuju. 13 weeks jangka kajinpa apply jarrinja wangu nyina child support-ku ngulaju kapunpa wita mani kurdu kurlanguju families (Family Tax Benefit)-ji kajinpa Child Support claim wangu nyina.

Nyiya child support-ju?

Child support-ju maniyi yangka kuja kapala payi mani ngati manu kirda nyanurlu warra-warra kanjaku kurdu-kurduku.

Nyampuju yangka families watirli yungulu maniyi mani yungulu jana kurdu-kurdu warra-warra kanyi.

Kajinpa pala nyuntu manu nyuntu-nyangu kurdu kurduku palangu jalpi nyina, ngulajulu jana warra-warra kangka juku.

Kaji kanpa claim-i mani Child Support-ju manu karnalu nyarra jirrama juku ngarrirni nganangku kaji ka payi mani child support-ju manu nyajangu talaju kaji ka payi mani. Services Australia Child Support staff-rli-rlangu kaji kalu nyarra puntarni maniyi nyampuju.

Accept-i maninjaku ngarnti nyuntu-nyangu claim-kiji ngulaju kaji karnalu jana check-i mani wiyi ngana birth parents kurdu kuju, marda kaji kanpa nganpa answer-mani nganimpa nyangu questions marda kaji kanpa nganpa pipa yinyi. Kaji karnalu jana wangkami kurdu yinyaku palangu birth parent-ki jinta kariki.

Apply jarrinjaku ngarnti child support-ku ngarntiji ngulaju wangkaya jana Child Support staff-ki.

3 ways-rli kaji kanpa mani child support-ju:

- 1. Nganimpa nyangu Child Support staff-rli kaji kangku puntarni maniyiji kaji:
  - nyampurlu nyiya kanti-kanti easy ngurrju mani nyuntuku
  - marda hard kanpa nyanyi wangkanjaku jinta kari birth parent-ki child support kurlu kuju
  - marda help yangka payments wati time-rla manu right amount-ku
  - help yangka child support maniyi jungarni maninjaku
  - jinta kari birth parent-rli nati tax returns yirrarnu.
- 2. Self Managed plan. Nyampuju private agreement nyuntu nyangu manu jinta kari birth parent kirlangu, marda parents yangka nyuntu jarra kurlangu kurdu-kurduku. Self Managed Plan kirli kujanpa pala milarnu mapirrirli:
  - nyajangu child support maniyi kanpalu mani
  - kaji jinta kari birth parent-rli nyuntu nyangu kurduku palangurlu payi mani child support maniyi.

Nganimpa nyangu Child Support staff natilpa plan nyampurla nyinyarla lawa.

Kajinpa milarni plan nyampu, ngulaju kaji kanpa kurdu kurlangu maniyiji witalku families mani.

3. Private Collect Plan. Nyampuju yangka Child Support wardingki paturlu marda court kapulu wangkami nyajangu child support maniyiji payi maninjakuju jinta kari birth parent-rliji. Nyunturlu manu jinta kari birth parent-rli marda kaji kanpala plan ngurrju mani nyarrparlu yungungku payi mani manu nyangurlarlu kapungku maniyiji payi mani.

Maya pina jarrinjaku information-ki ngulaju:

- yanta nyuntu nyangu local Services Australia (Centrelink) service centre kurra
- wangkaya jana Services Australia (Centrelink), kajili yanirra nyuntu nyangu community kirra
- ring-i manta jana Indigenous Call Centre kurra ngulaju 1800 136 380-rla manu payika jana yungunpa jana wangkami Indigenous Child Support wardingki patuku.

Kajinpa nganpa ring-i mani, ngarrika nganpa nyuntu nyangu Customer Reference Number (CRN) manu answer manta questions wati nyuntu kurlu, yungurnalu milya pinyi nyampuju nyuntu.

Payika jana interpreter-ku kajinpa nganpa ring-i mani manu yanirni, kapurnalu mani jinta free-ki.

## How Child Support affects your Family Tax Benefit

If you are getting Family Tax Benefit and you and the birth parent of your kid or kids are not together, you might need to apply for child support.

When you start getting Family Tax Benefit, you get 13 weeks to apply for child support. After 13 weeks, if you have not applied for child support you will get less families (Family Tax Benefit) money until you do a Child Support claim.

What is child support.

Child support is money the other birth parent or parents pay to help you look after them.

This is so you get enough families money to help you look after your kid or kids.

Even if you and the other birth parent of your kid are not together you both need to look after your kids.

You can claim Child Support and we can tell you and the other birth parent who needs to pay child support and how much they have to pay. Services Australia Child Support staff can also collect this money for you.

To accept your claim we need to check who the birth parents of the kids are, we may need you to answer some questions or give us some paperwork. We will usually need to talk to the other birth parent.

To apply for child support you will need to talk to our Child Support staff.

There are 3 ways for you to get child support:

- 1. Our Child Support staff can collect the money for you if:
  - this makes things simpler and easier for you
  - it is hard to talk with the other birth parent of your kid or kids about child support
  - you need help to make sure payments are on time and the right amount
  - you need help to get child support money back on track
  - the other birth parent does not lodge their tax returns.
- 2. Self Managed plan. This is a private agreement between you and the other birth parent, or parents of your kid or kids. With a Self Managed plan you both choose:
  - how much child support money will be paid
  - when the other birth parent of your kid or kids will pay the child support money.

Our Child Support staff do not need to be part of this plan.

If you choose this plan, you may get less families money.

3. Private Collect plan. This means our Child Support people or courts have said how much child support money the other birth parent of your kid or kids has to pay. All you and the other birth

parent have to do is make a plan about how they will pay you and when the money will be paid.

If you need more information you can:

- visit your local Services Australia (Centrelink) service centre
- talk to Services Australia (Centrelink) when they visit your community
- call the Indigenous Call Centre on 1800 136 380 and ask to speak to the Indigenous Child Support people.

If you call us, you will need to tell us your Customer Reference Number (CRN) and answer some questions about who you are, so that we make sure it is you.

You can also ask for an interpreter when you call or visit us. We will provide one for free.
