



Gun-guna janguny gu-weya Family Tax Benefit

Nginyipa Family Tax Benefit (FTB) ny-ma barra:

- minypa an-burrolga a-bambungana mun-nika
- jaga ny-janaja nula an-gungarda
- an-gungarda high school a-boya a-workiya o training a-boya a-workiya minypa gala mbi-ma aburr-workiya Centrelink rrupiya.

Nginyipa n-dimanga an-delipa minypa an-nerranga delipa aburr-bormunga burr-yika nginyipa ny-murna a-nirra nggula mun-gata minypa ny-ma barra ny-ji FTB.

FTB ny-ma barra, gu-gata wenga FTB claim start nyi-ni barra mu-ngoyurra nuwurra luka minypa gama, an-delipa ji-gochila a-yurra. Munurdiya minypa mun-nelangga pre-birth FTB claim nyi-ni barra 3 ran.gu guna-jinyirra.

Mun-guna minypa claim ny-ma barra FTB wenga:

- Burr-wu barra Tax File Number (TFN) rrapa an-gumarrbipa, o jin-gumarrbipa mun-nika TFN nyirrbu-gurdagarraga barra nyirrbu-wu barra TFN nula. Rrapa gun-nerranga gala n-dima TFN an-mujama aburr-gunggajiya barra nggula TFN nula, ny-ma barra. Boy burr-na, service centre gu-nginyipa rrawa yi-gurrepa nyi-nirra. Luka nginyipa burr-wenggana barra aburr-mujama aburr-welangga Services Australia (Centrelink) gun-gata birripa aburr-bengga barra yi-gatiya community.
- Burr-wu gun-nginyipa Customer Reference Number (CRN).
- Burr-gurdagarraga barra jurra Centrelink minypa an-gungarda gu-nginyipa ny-murna aburr-nirra.

Delipa a-bambungana wachpil nginyipa barra jurra pre-birth FTB claim ny-yukurjiiya barra. Delipa an-nelangga barra mu-jurra gu-guyinda a-rrima a-yu. Barra yanma Medicare card a-rrima a-yu luka Centrelink burr-wu barra.

Jal nyiburr-nirra janguny:

- nyiburr-boy barra Services Australia (Centrelink) service centre yi-gurrepa jama gurdiya rrawa
- minypa gu-yinpa barra Services Australia (Centrelink) aburr-mujama barra aburr-boy Maningrida, birripa nyirrbu-wenggana barra
- burr-wenggana barra Indigenous Call Centre gun-guna number 1800 136 380.

Nginyipa barra burr-wenggana barra, burr-wu barra gun-nginyipa Customer Reference Number (CRN) luka bubu-wenggana barra nyi-nga ny-yelangga luka ny-nyurriya barra nginyipiya.

Family Tax Benefit

You can get the Family Tax Benefit (FTB) if you:

- have a new baby
- have young kids in your care
- have kids in high school or approved study who are not getting a Centrelink payment.

You may also be able to get FTB if you are caring for a kid or kids that are not yours. This could be a kid or kids from your family who lives with you or you may be a kinship carer.

If you are going to have a baby, you can also start to get your FTB claim ready 3 months before your baby is born. This is called a pre-birth FTB claim.

When claiming FTB you need to give us:

- your Tax File Number (TFN) and if you have a partner, we need their TFN
- your Customer Reference Number (CRN)
- papers that show you are the carer for the kid or kids you are claiming for.

If you do not have a TFN, you can apply for one by visiting your local service centre or talking to Services Australia (Centrelink) when they visit your community.

If you have started your pre-birth FTB claim, we need the papers the hospital gives you after you have a new baby. We need these papers so we can finish your pre-birth FTB claim and also add your new baby to your Medicare card.

If you need more information you can:

- visit your local Services Australia (Centrelink) service centre
- talk to Services Australia (Centrelink) when they visit your community
- call the Indigenous Call Centre on 1800 136 380.

If you call us, you will need to tell us your Customer Reference Number (CRN) and answer some questions about who you are, so that we make sure it is you.

You can also ask for an interpreter when you call or visit us. We will provide one for free.
