



Ngirimipi kumawuni Family Tax Benefit

Nginja wiyi nuwunga awarra Family Tax Benefit (FTB) ngini nginja:

- juwuntiyi arrankini kirijini / kirijinga
- nginja nimpamangi kakirijuwi
- ngini kakirijuwi kapi high school arramini approved study ngini karluwu nuwuni Centrelink payment.

Nginja wiyi nupunga nanki FTB ngini nginja tayamangi awuta kapinaki kakirijuwi ngini karluwu nuwula. Arrami wuta kakirijuwi nuwa ngirimipi kinship carer.

Karri mamparra nipirtimarti kakirijuwi, nginja wiyi awunganji FTB claim ready 3 months arlapala karri kakirijuwi wumulungurumi. Awarra nanki wurimamula pre-birth FTB claim.

Karri nuwunga awarra FTB nginja wiyi nimarra kapi ngawa:

- nginingijila Tax File Number (TFN) amintiya nginja-mantani / mantanga (partner), ngawa nanginta ngini wuta TFN
- ngini ngijila Customer Reference Number (CRN)
- jurra ngini nginja wutayamangi nginja-mwaruwi amintiya yingwampa kakirijuwi ngini nginja wutamangi kapi awarra pikaringini ampingira.

Ngini karluwu nuwuni TFN, nginja wiyi apply natinga by visiting your local service centre arrami nimarra kapi awuta Services Australia (Centrelink).

Ngini nginja mampara nginingijila pre-birth FTB claim, ngawa ngiimpirtimarti jurra ngini wuta hospital apakirayi nginja karri juwurnti nginja-mwaruwi. Ngawa ngimpirtimarti jurra pili ngawa awarra ngapapaya nginingijila pre-birth FTB claim amintiya japamakuri yintanga wuta kakirijuwi kapi nginingijila Medicare card.

Ngini nginja nuwurtumarti tuwanga awarra ngirramini (information)

Ngini nginja nuwurtumarti tuwanga nginanki ngirramini information nginja wiyi:

- nuwurri awunganji kangi nuwa local Services Australia (Centrelink) service centre
- nimarra kangi Services Australia (Centrelink) karri wuta kapi nuwa community
- call kiyi nimarra kapi awuta Indigenous Call Centre kapi 1800 136 380.

Family Tax Benefit

You can get the Family Tax Benefit (FTB) if you:

- have a new baby
- have young kids in your care
- have kids in high school or approved study who are not getting a Centrelink payment.

You may also be able to get FTB if you are caring for a kid or kids that are not yours. This could be a kid or kids from your family who lives with you or you may be a kinship carer.

If you are going to have a baby, you can also start to get your FTB claim ready 3 months before your baby is born. This is called a pre-birth FTB claim.

When claiming FTB you need to give us:

- your Tax File Number (TFN) and if you have a partner, we need their TFN
- your Customer Reference Number (CRN)
- papers that show you are the carer for the kid or kids you are claiming for.

If you do not have a TFN, you can apply for one by visiting your local service centre or talking to Services Australia (Centrelink) when they visit your community.

If you have started your pre-birth FTB claim, we need the papers the hospital gives you after you have a new baby. We need these papers so we can finish your pre-birth FTB claim and also add your new baby to your Medicare card.

If you need more information you can:

- visit your local Services Australia (Centrelink) service centre
- talk to Services Australia (Centrelink) when they visit your community
- call the Indigenous Call Centre on 1800 136 380.

If you call us, you will need to tell us your Customer Reference Number (CRN) and answer some questions about who you are, so that we make sure it is you.

You can also ask for an interpreter when you call or visit us. We will provide one for free.
