



Family Tax Benefit

Kaji kanpa mani Family Tax Benefit-ji (FTB) kajinpa:

- kurdu pirltirrka mardani
- kurdu wita wita mardani nyuntu nyangu care-ngka
- mardani kurdu kurdu high school-rla marda study jarrimi ka Centrelink payment maninja wangu.

Kaji kanpa mani FTB-ji kajinpa jana kurdu kurdu mardani nati nyuntu nyangu. Nyampurra kurdu kurdu marda nyuntu nyangu family kirlangu kuja kalu nyina nyuntu kurlu, mardanpa kinship carer.

Kajinpa kurdu pirltirrka mardani, kaji kanpa nyuntu nyangu FTB claim yirrarni 3 month kurduku ngarnti palka jarrinjaku ngarntiji. Nyampuju irtiji pre-birth FTB claim.

Kajinpa claim-i mani FTB ngulaju nganpa yungka:

- nyuntu nyangu Tax File Number (TFN) manu kajinpa kali nyanu mardani, nyanungu nyangurlangu nganpa TFN yungka
- nyuntu nyangu Customer Reference Number (CRN)
- pipa yangka ka nganpa milki yirrarni nyuntu carer-ju kurdu kurdu kuju, kuja kanpa janarla claim-i mani.

TFN wangu ngulaju apply jarriya nyuntu nyangu local service centre wana marda wangkaya jana Services Australia (Centrelink) kajili yanirra nyuntu nyangu community kirra.

Kajinpa rdirri-yungu pre-birth FTB claim, ngulaju nganpa yungka pipa hospital jangka kuja kalu nyarra yinyi kurdu pirltirrka mardaninja warnuku. Pipa nyampurrarlu nganpa yungka yungurnalu finish mani nyuntu nyangu pre-birth FTB claim, manu add-i manta nyuntu nyangu kurdu jalangu warnu Medicare card-rla.

Information-ki maya pina jarrinjaku

Information-ki maya pina jarrinjaku, ngulaju:

- yanta nyuntu-nyangu local Services Australia (Centrelink) service centre kurra
- wangkaya jana Services Australia (Centrelink) ki, kajili yanirra nyuntu-nyangu community kirra
- ring-i manta jana Indigenous Call Centre ngulaju 1800 136 380-rla.

Kajinpa nganpa ring-i mani, ngulaju nganpa ngarrika nyuntu-nyangu Customer Reference Number (CRN) manu yalu manta jana questions wati yangka nyuntu kurlu, yungurnalu milya-pinyi nyampuju nyuntu.

Kaji kanparla payirni interpreter-ku kajinpa nganpa yanirni nyanjaku. Kapurnangkulu mani jinta free-ki.

Family Tax Benefit

You can get the Family Tax Benefit (FTB) if you:

- have a new baby
- have young kids in your care
- have kids in high school or approved study who are not getting a Centrelink payment.

You may also be able to get FTB if you are caring for a kid or kids that are not yours. This could be a kid or kids from your family who lives with you or you may be a kinship carer.

If you are going to have a baby, you can also start to get your FTB claim ready 3 months before your baby is born. This is called a pre-birth FTB claim.

When claiming FTB you need to give us:

- your Tax File Number (TFN) and if you have a partner, we need their TFN
- your Customer Reference Number (CRN)
- papers that show you are the carer for the kid or kids you are claiming for.

If you do not have a TFN, you can apply for one by visiting your local service centre or talking to Services Australia (Centrelink) when they visit your community.

If you have started your pre-birth FTB claim, we need the papers the hospital gives you after you have a new baby. We need these papers so we can finish your pre-birth FTB claim and also add your new baby to your Medicare card.

If you need more information you can:

- visit your local Services Australia (Centrelink) service centre
- talk to Services Australia (Centrelink) when they visit your community
- call the Indigenous Call Centre on 1800 136 380.

If you call us, you will need to tell us your Customer Reference Number (CRN) and answer some questions about who you are, so that we make sure it is you.

You can also ask for an interpreter when you call or visit us. We will provide one for free.
