



Family Tax Benefit

Unta antjanama arrarnalitjika inatjika Family Tax Benefit (FTB):

- unta paka inakala katjia kurrka nthurra
- unta paka katjia kurrka ntarntaramanga
- unkwanganha katjia high school-ka irrpuma or approved study-ka unta paka itja inamala Centrelink payment parta.

Unta paka arrarnalitjika inatjika Family Tax Benefit unta paka ntarntaramanga katjia ntjaarranha, unkwanga itja etna nama katjia nhanha ntjaara paka family unkwanganhaka etna namalanga ntarntararinya unkwanga.

Unta paka katjia kurrka inamala unta arrarnalitjika FTB claim-ka 3 month arrkurla unkwanganha katjia kurrka inatjina nhanha ilama pre-birth Family Tax Benefit claim arrarnalitjika.

Unta paka arrarnalama Family Tax Benefit-ka, unta nurnanha thitjaka unkwanganha:

- Tax File Number (TFN) unkwanga unta paka mitakurta namanga etna antjanama ekuranha Tax File Number-ka turta
- Customer Reference Number (CRN) unkwanganha
- pepa nhanhala ntelama unta ntarntaramanga katjia ntjaarranha unta paka pmaaratjika etnaka.

Unkwanganha itja paka nama Tax File Number unta paka inatjika unkwanganha service centre-urna, unta angkitjika Services Australia (Centrelink) ilangara paka etna pmara unkwanga-urna ilatjna.

Unta paka arrarnakala unkwanga pre-birth Family Tax Benefit claim, nurnanha antjanama pepa nhanhaka hospital-nga nganha nthakala ingkarna katjia kurrka intamanga, nurna antjanama nhanha ntjaarra pepaka nurna unkwanga rraatja-ilama, unkwanga pre-birth Family Tax Benefit claim nhanha unkwanga katjia kurrka unta arrarnatjika Medicare card-ka.

Unta paka yia wutha wutjika antjanama

Unta paka yia wutha wutjika antjanama, nhanha aratjika:

- unta lhatjika etnanha aratjika Services Australia (Centrelink) service centre pmara unkwanganhanga
- unta angkitjika Services Australia (Centrelink)-lela etna pitjimanga pmara unkwanganha-urna
- unta ring-melitjika Indigenous Call Centre nhanhanga 1800 136 380.

Unta paka nurnanha ring-melamala, nurnaka ilatjika Customer Reference Number (CRN) unkwanganha, ilatjika yia unkwanga epenha turta. Nurna lhangkaratjinanga nganha.

Unta ring-melamanga, thunga unta pitjimanga nurnanha aratjika, unta paka antjanama interpreter-ka, nurna nganha free one nthima.

Family Tax Benefit

You can get the Family Tax Benefit (FTB) if you:

- have a new baby
- have young kids in your care
- have kids in high school or approved study who are not getting a Centrelink payment.

You may also be able to get FTB if you are caring for a kid or kids that are not yours. This could be a kid or kids from your family who lives with you or you may be a kinship carer.

If you are going to have a baby, you can also start to get your FTB claim ready 3 months before your baby is born. This is called a pre-birth FTB claim.

When claiming FTB you need to give us:

- your Tax File Number (TFN) and if you have a partner, we need their TFN
- your Customer Reference Number (CRN)
- papers that show you are the carer for the kid or kids you are claiming for.

If you do not have a TFN, you can apply for one by visiting your local service centre or talking to Services Australia (Centrelink) when they visit your community.

If you have started your pre-birth FTB claim, we need the papers the hospital gives you after you have a new baby. We need these papers so we can finish your pre-birth FTB claim and also add your new baby to your Medicare card.

If you need more information you can:

- visit your local Services Australia (Centrelink) service centre
- talk to Services Australia (Centrelink) when they visit your community
- call the Indigenous Call Centre on 1800 136 380.

If you call us, you will need to tell us your Customer Reference Number (CRN) and answer some questions about who you are, so that we make sure it is you.

You can also ask for an interpreter when you call or visit us. We will provide one for free.
